A. FORMAT YOUR ABSTRACT

Please write your abstract in English using either Microsoft Word or PDF format.

B. PROOFREAD

Be sure to *proofread* your submission to confirm that it contains all the information you want to include before submitting your abstract.

C. PRESENTING AUTHOR AND ADDITIONAL AUTHORS

When listing your authors, you must designate a presenting author. It is recommended that the presenting author also be the submitter of the abstract. All correspondence will be sent to the submitter. The authors can be listed in any order you designate.

D. SUBMIT YOUR ABSTRACT

GUIDELINES for APPROVED POSTER PRESENTERS

Please do not register until your poster has been approved. You will be given a discount code to register at a reduced price if your presentation is approved.

Poster presenters must arrive at the USP Meetings Center during the registration period on September 21, 2015 to display their poster. Posters are to be set and ready by the start time of the workshop.

Posters will be mounted in common areas and available for viewing throughout the duration of the Workshop. Presenters are encouraged to stand by their poster during the break times so as to be available for any questions that may arise. Posters can be removed at the conclusion of the workshop.

An 8.5 x 11 PDF version of your poster may also be included in the on-site program along with a one-page biography of the authors.

Please note the following with regard to the creation of your scientific poster:

- 1) The display board is 8' (feet) wide by 4' (feet) high. The mounting surface is 7' (feet) 6" (inches) wide by 3' (feet) 6" (inches) high (landscape orientation). It is recommended that your poster presentation, fill the "usable space" of the board as much as possible.
- 2) Handout materials may be included in an envelope attached to the display board. Only poster related materials are allowed (no sales flyers). All non-poster related materials will be removed.
- 3) We will provide push pins for you. Please do not use tape or other adhesives.
